Our Autumn Lunch this year is **A VISIT FOLLOWED BY LUNCH** to the Historic Property called **Chavenage House, Tetbury GL8 8XP a Grade 1 listed building** dating from the late 16<sup>th</sup> century. The house is constructed in the Elizabethan style with Cotswold rubble stone with a stone slate roof and has two storeys plus attics. It has large windows to the south of the porch, much of the glass being obtained from redundant churches & monasteries.



The television addicts will recognise the property as Trenwith which was the name of land owned by the Poldark family who lived in Trenwith House.

Fortunately, we do not have to go to Cornwall as the BBC realised that Chavenage House was almost identical to Trenwith, that being the actual setting of Winston Graham's Novel, Poldark.

You do not need to be a Poldark fan to enjoy this wonderful house. **The Lowsley-Williams** family will give us an

entertaining guided tour of their property, it's a long & fascinating History, that dates back to 1576.
